Mississippi residents can still choose to only rely on their physical ID, but many residents will find Mobile ID is convenient, secure and private. It will easily allow residents to always have an up-to-date driver's license or ID. It can be used as a legal form of identity verification anywhere in the state users would normally show their driver's license and expands users' ability to provide proof of identity online.
